1 WHEREAS, on May 20, 2013, the Court stayed the case for 30 days in light
2 of Dominique R. Shelton’s – lead counsel for Plaintiffs eDrop-Off Chicago LLC
3 and Corri McFadden (collectively, “Plaintiffs”) – departure from Edwards Wildman
