felt a description of prior events was in order since assumptions have been made on The Plaintiff's character within the Defendant's documents.



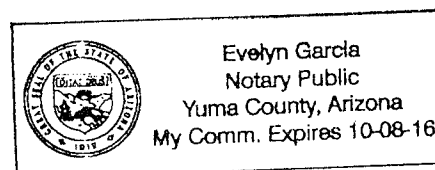


